### Executive Summary

An Ageing in Place project was commenced by Gympie Regional Council in August 2020. The project purpose was to investigate Ageing in Place services and infrastructure in the Gympie region with an initial focus on the Western area.

Ageing in place has been defined as “the ability to live in one’s own home and community safely, independently and comfortably, regardless of age, income or level of capacity. Ageing in the right place extends this concept to the ability to live in the place with the closest fit with the person’s needs and preferences – which may or may not be one’s own home” (World Health Organisation. 2015. World report on ageing and health) <https://www.who.int/publications/i/item/9789241565042>

The Final Report culminating from this project was presented to Gympie Regional Council’s Ordinary Meeting on 28 June 2022. This Implementation Progress Report provides a summary of actions undertaken in 2023/2024.

In 2024/2025, Council Officers will continue to progress actions outlined in the Ageing in Place Report within allocated Council funding and resources, as enhanced by external funding.

In 2023-2024 Gympie Regional Libraries delivered a total of 421 digital literacy sessions (either one-on-one or group) attended by a total of 1245 people. All aqua and land sessions are designed to be inclusive and cater to a broad demographic including seniors. In the month of April 2024, 1235 attendees participated at these ARC sessions, with approximately 83% of participants over sixty years old. Community groups such as Bravo and Gympie RSL also host group sessions at ARC. Seniors also often organise social gatherings and meet ups around the programming, increasing mental and social wellbeing. Seniors seasonal membership at the regional pools is higher with 41.03% at Kandanga, 54.55% at Tin Can Bay and 50% at Goomeri.</p>

All projects awarded grants had a strong volunteering component or volunteering involvement.</p> <p>2023/2024 Community Grants Programs extended eligible expenses to include Project Coordinator costs which goes some way to relieve the volunteering burden on community organisations delivering projects.</p> <p>A series of video resources were created to support and promote volunteering in the Gympie region.
